He stated this will be coming out of next year's budget and we should pay for it as a whole to save an extra 10%. Mayor Martin asked for a motion to move forward with the updates. Trustee Ellen Hibbard made a motion to move forward with the upgrades, seconded by Joanne Seefeldt. All in favor, motion unanimously approved.

Event Request for Wilson Star Search: Mayor Martin read the Wilson Star Search event request. Attorney Mike Dowd has reviewed and insurance has been provided. Trustee Joanne Seefeldt made a motion to approve the events, seconded by Trustee Doug Kepner. All in favor, event request unanimously passed.

Tronconi Segarra & Associates Engagement Letter: Mayor Martin explained that there is a small increase from last year, however, they have been great to work with and is requesting a motion to approve. Engineer Mike Marino reported that he will be submitting the engineering planning grant with the resolution passed tonight. Working on our current grants. Should have a kick-off meeting soon for the water assessment management plan.

Shawn Galyen, Superintendent of Public Works was not able to be here tonight.

Trustee Joanne Seefeldt stated that there is a Tree Committee meeting on the 21st of April at 3 pm.

Trustee Ellen Hibbard has nothing at this time.

Attorney Michael Dowd has nothing at this time.

Clerk Treasurer Carey O'Connor has nothing at this time.

Trustee Doug Kepner has nothing at this time.

Mayor Greg Martin wanted to report our ongoing Grant plans and what's going on. He asked Mike Marino about when the ZEV grant may be announced. Mike hasn't received any updates as of today. Mayor Martin stated:

- we are still working on our ongoing water asset management plan.
- the NYS Main Street Technical assistance study.
- the EPG I&I study.
- the LWRP meeting is next week to discuss the boundaries.
- Grants we've applied for, ZEV grant (electric charger), EPG WWTP Grant Study, Smart Growth updates and we will reapply for that. Martin Park project grant (CFA grant), we are also working with a local non-profit on this project as well.
- have sent in for two congressional requests with Gilibrand and Shumer. Will submit to Tenney as well when that opens.
 - working on the Climate Smart status. Hoping to be Bronze status this summer. This will help us with grants.
- we were awarded 50,000 for a SAM Grant in 2017 and it was finally awarded in 2022 but did not know until this morning. We will be working with Mike on what we can do with this to get it done by July.
 - Climate Smart Committee meeting with be April 14th.

- Wander About Wilson bike campaign. He's taking bikes to be repaired tomorrow. We will be getting our waiver up soon. We received \$800 from Dave Godfrey at Niagara County to help us purchase bike racks.
 - received a quote for some signage at the 425/Townline Pier. This completes the parks plan for the pier.

Mayor Greg Martin closed reports.
